1 Purpose

2 Categories and Prizes

This art Competition is an opportunity for everyone to visually communicate ways to address and bring about change, whether it is for an individual, a community, a family, or friends, to end domestic and family violence.

- CDVC welcomes works any medium including but not limited to original painting, drawing, photography, digital art, sculpture etc.
- Entry is open to people of all ages, both professional and amateur Artists.

Entry Cost:

- Adult: \$35
- Child (14 & under): \$15
- Concession: \$20

All Competition fees are non-refundable. Artists will receive a receipt of entry upon lodgement.

DV Through Their Eyes First Prize Categories

- Open Adults – cash prize of \$250
- People's Choice – cash prize of \$50
- Under 14s – cash prize of \$25

There is only one winner per category.

3 Promotion

DV Through Their Eyes Art Competition and Award Event (**Event**) is supported by Sector Connect Inc., Campbelltown City Council, Club GRANTS and Wests Group Macarthur.

The winners' Artwork will be used by CDVC in advertising material and resources, such as cards, pamphlets, and saleable items for further fundraising, with full acknowledgment of the Artist.

All entries will be displayed on the CDVC website and social media.

Entries can be marked for sale, and are to be available to be displayed at various locations from **22/11/23 to 31/12/23**.

All funds raised through the Event will be used by the CDVC to promote and raise awareness of domestic and family violence.

TERMS & CONDITIONS

1 Summary of Competition

- (1) This art competition (**Competition**) is run by the Campbelltown Domestic Violence Committee (**CDVC**) in the state of NSW, Australia only.
- (2) The Application Form and these Terms & Conditions (**T&C**) together make up the Artist's entry form (**Entry**).
- (3) By entering this Competition, the Artist agree to accept these T&C.
- (4) If the Artist's Entry does not comply with these T&C, the Artist's Entry will not be valid and will not be accepted.
- (5) Entrants aged under 18 years of age must obtain their parent or guardian's consent to enter this Competition.
- (6) Entrants aged under 18 years of age acknowledge that CDVC may contact the parent/guardian stated in the entrant's application form at any time for the purpose of confirming that consent has been provided.
- (7) The Competition opens at **9:00 am** on **14th July 2023** and closes at **5.00 pm** on **14 October 2023 (Competition period)**.
- (8) Entries received outside of this Competition Period will not be accepted.
- (9) To validly enter the Competition, during the Competition Period, the Artist must:
 - (a) visit <https://www.dvhelp.org.au>; and
 - (b) email thegenderequityproject@gmail.com; and
 - (c) upload a digital image of the Artist's Artwork (see clause 8); and
 - (d) submit a properly completed application form, including a 50-100 word Artist's statement; and
 - (e) pay the non-refundable administration fee via Electronic Funds Transfer to the following account:

- (10) Digital images of the Artist's Artwork must be in JPEG format; between 1mb and 3mb in file size; at 300 dpi resolution; and saved using the following file name format: **surname_firstname_titleofartwork**.
- (11) A maximum of two (2) Artworks per entrant will be accepted.
 - (a) Artwork entered into the Competition must:
 - (b) have been completed after 1 February 2018;
 - (c) be available for display at the Award Event (and other sites chosen by CDVC) between **23 November 2023** and **31 May 2024**;
 - (d) be no larger than 1.5m x 1m in dimension;

- (e) weigh no more than 10 kilograms;
 - (f) be professionally prepared for hanging and/or installation; and
 - (g) be clearly marked on the reverse with the entrant's name, address and the title of the Artwork.
- (12) If the Artwork is made available for sale:
- (a) The sale price should be GST inclusive.
 - (b) If the Artist are a registered business an ABN must be supplied.
 - (c) Payment from the sale of Artwork sold, excluding the 30% commission, will be made to the Artist within 60 business days of receipt of full payment from the purchaser of the Artwork.
 - (d) All finalists must provide bank details that will be used to receive payment of any sold works.

2 Copyright & Warranties

- (1) Entries must be the Artist's own original work and must not contain any objectionable, profane, insulting, inflammatory or defamatory material, or infringe a third party's intellectual property rights.
- (2) All works must be made solely by the Artist and be the property of the Artist.
- (3) Entrants acknowledge and agree that the Artist retains copyright in their Artwork.
- (4) Entrants represent and warrant that the work is the entrant's sole, original work, the entrant has the power to grant the rights given under it, the entrant has obtained appropriate releases (if any), the entrant is entitled to reproduce and exploit any underlying rights in the work, and the entrant indemnifies CDVC against any loss resulting from breach of these warranties.
- (5) A breach of any of the T&C under this section will result in disqualification of the Entry.

3 Privacy

- (1) Where a person is capable of being identified in the Artist's Entry, the Artist must obtain that person's consent (or the consent of their parent or legal guardian if they are aged under 18) for the Entry to be entered into this Competition and displayed and published in accordance with these T&C.
- (2) Evidence of receipt of any such consent must be provided to CDVC upon request.
- (3) Personal information collected as a consequence of entry into this prize will comply with privacy provisions.
- (4) CDVC will use personal information only for the purposes related to the events and Competition.

4 Exhibition and judging

- (1) Judging to shortlist entries will commence on **14 October 2023**.
- (2) Shortlisted entrants will be contacted by CDVC no later than **20 October 2023**.

- (3) Finalists and winners are invited to attend the Award Event held at West Leagues Club, on **22 November 2023 (4pm – 7pm) (Award Event)**.
- (a) If an Artist's work is selected as a finalist, work must be available for exhibition and sale at the Award Event.
 - (b) In consultation with CDVC, Artists will nominate a sale price on the back of their Artwork.
 - (c) Artists are responsible for paying all travel costs and expenses incurred if they wish to attend the Award Event. They are not required to attend and CDVC will not reimburse travel expenses.
- (4) The judges will determine one (1) Competition winner from all shortlisted entries in three (3) categories:
- (a) **First Prize Open** – the winner will be announced at the Award Event.
 - (b) **People's Choice Award** – the winner will be awarded to the entrant whose Artwork receives the most votes from visitors to the Award Event. The winner of the People's Choice Award will be announced at an exhibition launch to be held on social media online on **24 November 2023**.
 - (c) **Children under 14** – the winner will be announced at the Award Event.
- (5) Winners will receive the relevant cash prize amount listed below (total prize pool valued at \$325).
- (a) *DV Through Their Eyes Open Art Award* – cash reward of \$250.
 - (b) People's Choice Award – cash reward of \$50.
 - (c) Children under 14 Award – cash reward of \$25.
- (6) The Judges' decision is final. No correspondence will be entered into.
- (7) Campbelltown City Council may, acting in its entire discretion, determine not to display a shortlisted entrant's Artwork at the Campbelltown Council Chambers.
- (8) All winners consent to their names and images of their Artwork being published by CDVC in connection with this announcement.
- (9) All winners' names will subsequently be published in a *DV Through Their Eyes Art Prize* media release and on the CDVC website and social media pages.
- (10) All winners' names and images of winning Artwork will be published in Campbelltown City Council and Wests Club newsletters.
- (11) If a prize has not been claimed within two (2) business days of being contacted, the winner will be deemed to have surrendered the prize and CDVC may opt to conduct further judging to award the unclaimed prize.
- (12) Campbelltown DV committee reserves the right not to award a prize in any category.
- (13) Prizes are not transferable.

5 Delivery of Artwork

- (1) Shortlisted entrants must, at their own cost and at their own risk, ensure that their Artwork is delivered to Campbelltown City Council in **November 2023** (between the hours of **10:00 am** and **4:00 pm only**).
- (2) Artists must, at their own cost and at their own risk, collect their Artwork from Campbelltown City Council (further details will be provided by CDVC in relation to time and date for collection).
- (3) Artwork is submitted at the entrants' own risk (from delivery to pick up).
- (4) The Artist acknowledge and agree that if the Artist do not collect the Artist's Artwork from the collection site within seven (7 days from when requested the Artist's Artwork:
 - (a) will be deemed to be abandoned;
 - (b) will become the property of the CDVC; and
 - (c) may be disposed of in any manner as CDVC sees fit, including by sale or auction.
- (5) CDVC is not responsible for any insurance, delivery costs or freight of works during delivery.
- (6) CDVC is not responsible for any works lost or damaged during delivery or late delivery of works that may not be exhibited.
- (7) If the shortlisted entrant uses a courier to deliver and collect their Artwork, they must ensure their Artwork is sufficiently packed for delivery, provide their return postal address, and supply CDVC with a consignment note for collection of the Artwork by a courier by **4:00 pm** on **30 November 2023**. CDVC will repackage the Artwork prior to the collection using the existing packing only.
- (8) Framing or mounting of works, for exhibition, is also the responsibility of the Artist and must be carried out prior to delivery. If required by CDVC, shortlisted entrants must also provide installation instructions for their Artwork.

6 Licence to use Artwork

- (1) Shortlisted entrants and winners grant CDVC an irrevocable, royalty-free, non-exclusive, non-commercial licence to display, publish and otherwise use their Artwork (in whole or in part) for a period of 12 months:
 - (a) as part of the *DV Through Their Eyes* Art Prize exhibition and online at <https://www.dvhelp.org.au> between **24 November 2023** and **24 November 2024**; and
 - (b) for the purpose of any promotional material, advertising, and marketing for sale of the Artwork for fundraising, including in print or online. and whether published by CDVC itself or through a third party on CDVC websites and social media pages.
- (2) When displaying, publishing or otherwise using the Artwork in accordance with subparagraph (1)(b) above, CDVC will always credit the Artist using the name provided in their Entry.
- (3) CDVC may also use the Artist's biographical information through these promotions unless the Artist has requested to remain anonymous.

- (4) Any digital display of the works will be low resolution to prevent copying. When reproducing no changes or alterations will be made to the Artwork without prior written consent of the Artist. CDVC may request shortlisted entrants' social media handles or profile links, which CDVC may, acting in its absolute discretion, publish in connection with publishing the Artwork in accordance with subparagraph (1) above.

7 General

- (1) CDVC accepts no responsibility for late, lost, incomplete, corrupt, or invalid entries.
 - (2) If for any reason beyond CDVC's reasonable control, be it man made or natural disaster, e.g., flood, fire, pandemic, strike, government direction or other emergency that prevent CDVC from holding the Competition and/or Award Event, CDVC can cancel, terminate, modify or suspend the Competition/Award Event.
 - (3) In such a case, in consultation with CDVC, all submitted works will remain the property of the Artist and available for their collection and entry fees are refundable. Competition
 - (4) CDVC reserves the right to change or modify these T&C at any time.
 - (5) In the event of a dispute regarding the interpretation of these T&C, the decision of CDVC shall be binding on all parties.
